A 5-session virtual event: One unique 2-hour session topic will be presented every Wednesday from January 10, 2024 through February 7, 2024 at 12:00 – 2:00 PM CST.

Early Head Start BITES is a series dedicated to learning the appropriate practices in engaging infants and toddlers while guiding and understanding the behaviors of infants and toddlers. The event will provide 10 clock hours of training that will be beneficial for Early Head Start teaching staff, family child care staff, home visitors, center managers, and anyone else interested in understanding how to appropriately engage and guide children's behavior in Early Head Start.

Daily transitions are an important key for setting the tone for daily routines and encouraging appropriate behaviors.

This session will focus on the environment, how environments are arranged, the materials and equipment available, and how the environment impacts behaviors.

We will take this time to discuss the social and emotional outcomes that are expected for Early Head Start children and how to ensure appropriate practices while encouraging school readiness.
